**Application Fee:** 

All candidates, except SC/ST should submit a "Crossed Demand Draft for Rs.100/- (Rupees One Hundred only) issued by any nationalized Bank. The Demand Draft should be drawn in favour of "Pay & Accounts Officer", Dr. R.M.L. Hospital, payable at New Delhi.

## **Eligibility for Applicants:**

Applicant must fulfil the educational qualification, experience and age limit and other criteria for the post applied for, as on the last date of receipt of the applications, failing which the application shall be summarily rejected and no correspondence will be entertained in this regard. Candidates are therefore, advised to satisfy themselves before applying for the post that they possess the requisite essential qualification and experience. The prescribed essential qualifications are the bare minimum and mere possession of the same does not entitle candidates to be called for the interview/ selection.

The minimum age indicated for the post is general category candidates. Relaxation in upper age limit will be available to SC/ST/OBC/Physically Handicapped candidates and others as per Govt. of India instructions issued from time to time.

#### **Scheme of Selection:**

Selection to the aforesaid post will be on the basis of written examination or interview which will be conducted by a duly constituted Selection Committee. However, if the number of applications received for a particular post is large, then hospital reserves the right to lay down any criteria for the purpose of short listing of the candidates for interview.

### **Last Date for Receipt of Application:**

Application in the prescribed pro forma along with application fee and attested photocopies of all certificates for age, educational qualification, experience and SC/ST/OBC certificates, if any etc. must reach to the undersigned within 30 days from the date of publication of this advertisement.
