2. **Eligibility:**

- MBBS with PG degree in Medicine from a recognized university (as well as the speciality recognized/permitted by MCI).
- Should be registered with Delhi Medical Council (DMC) or applied for registration (Proof to be enclosed).
- The candidate should complete the tenure of Degree on or before 29.12.2016.

3. **Pay Scale:**

Pre-revised pay band Rs. 15600-39100/- with Grade pay Rs 6600/- and revised pay in Pay Matrix (Level 11) under CCS (Revised Pay) Rules, 2016. Allowances as admissible will be paid.

4. **Age Limit:**

- a) Not exceeding 33 years as on 29.12.2016

6. **Terms & Conditions:**

- i) Crucial date of determination of eligibility with regard to age will be **29.12.2016**
- ii) Candidates must be registered with Delhi Medical Council before joining the post, if selected.
- iii) Other service conditions will be applicable as per service condition prescribed from time to time by the Government of India.
- iv) The candidate who is already in Govt. Service should submit No Objection Certificate from the present employer.
- v) The candidates must submit the copy of following documents (self-attested) along with application form. They should bring the original certificates at the time of interview:

 - 7) Proof of publication/presenting paper in conference.
- vi) The candidates must submit the application in the prescribed form (Annexure-I) and paste recent passport size photograph on it. All the documents must be self-attested including his/her photograph on the application form.
