### **Advertisement for the post of Dietician**

Medical Superintendent, Dr. Ram Manohar Lohia Hospital proposes to fill up the 03 posts of Dietician on regular basis, as per the details given below. Eligible candidates who fulfill the eligibility criteria as mentioned below may apply: -

**Name of Post :** Dietician  
**No. of Post :** 03 (Three) (UR – 2) (OBC – 1)  
**Scale of Pay :** Pay Matrix Level – 7 ₹ 44900 – 142400/-  
(Pre-revised PB - 2 ₹ 9300 – 34800 + Grade Pay ₹ 4600/-)

**Age –** Not exceeding 30 years

- Note 1 : (Relaxable for Government servants up to five years in accordance with the instructions or orders issued by the Government)
- Note 2 : The crucial date for determining the age limit shall be the closing date for receipt of application and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura; Sikkim, Ladhak Division of Jammu and Kashmir State, Lahaul and Spiti District and Pangai Sub-Division of Chamba District of Himachal Pradesh, Andaman and Nicobar Islands and Lakshadweep.

### **Educational and other qualification required:** **Essential :**

- (A)(I) Master's Degree in Food and Nutrition or Home Science or Home Economics or Clinical Nutrition and Dietetics from a recognized University or Institute.  
or  
(II) Master's Degree in Food Science and Nutrition or Food and Nutrition Dietetics or Dietetics and Food Services Management from a recognized University or Institute.  
or  
(B)(I) B.Sc. Food and Nutrition or Food Science and Nutrition or Home Science or Home Economics or Clinical Nutrition and Dietetics or Food and Nutrition Dietetics or Dietetics and food service management from a recognized University or Institute; and  
(II) Post Graduate Diploma in Dietetics from a recognized University or Institute; and  
(III) One year practical experience in Dietetics in a 100 bedded hospital or organization under the Central or State Government or Autonomous or Statutory body or Public Sector Undertaking or University or recognized research institute.

### **Eligibility for Applicants:**

Applicants must fulfill the educational qualifications, experience and age limit and other criteria for the post applied for, **as on the last date of receipt of the applications**, failing which the application shall be summarily rejected and no correspondence will be entertained in this regard. Candidates are, therefore, advised to satisfy themselves about their eligibility before applying for the post that they possess the requisite essential qualification and experience. The Hospital will not enter into any correspondence on their ineligibility. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle candidates to be called for the interview/selection.

**Note:** All Government Servants, including the officials working in this Institution, shall apply after obtaining the age relaxation certificate (copy of age relaxation certificate to be enclosed) from their concerned Department/Ministry for claim for age relaxation.

**Scheme of Selection:**

Selection to the said posts will be on the basis of written examination and interview, which will be conducted by a duly constituted Selection Committee.

**Last Date for Receipt of Application:**

Application in the prescribed pro forma as given at **Annexure – I**, addressed to **The Medical Superintendent, Dr. Ram Manohar Lohia Hospital, New Delhi – 110 001** should reach on or before expiry of 45 days from the date of publication of advertisement along with the attested photocopies of all certificates for age, educational qualification, experience etc.

Application (s) received after the last date or without relevant documents / incomplete documents / unsigned application or without application fee shall be summarily rejected. The hospital authorities shall not be responsible for any postal delay.

Candidates in Central/State Govt./PSU/UT service whether in permanent or temporary capacity are required to submit their applications through proper channel along with NOC.

Candidates shall be governed by the new restructured defined Contributory Pension Scheme as notified by the Central Government.

**NOTE:**

- 1) Vacancies likely to increase or decrease at the time of screening test.
- 2) Candidates should state as to whether the institute / university awarding the degree is recognized or not and the name of the recognizing authority. Copy of letter of recognition is to be enclosed; failing which application would be rejected.
- 3) Appointing authority reserves the right to withdraw the said notification at any time.
- 4) The prescribed essential qualifications are the minimum and mere possession of the same / fulfilling of eligibility criteria does not entitle candidates to be called for the test.
- 5) The hospital will not enter into any kind of correspondence on their ineligibility or rejection of candidature.
- 6) All government servants, including the officials working in this Institution, shall apply along with the No Objection Certificate & age relaxation certificate duly obtained from their concerned Department / Ministry, for claim for age relaxation.
