The candidates are requested to **report at 9:30 AM on 15/02/2018 at Room No. 107, Administrative Block, PGIMER, Dr. RML Hospital** and to bring application on plain paper either typed or neatly handwritten, bio-data, two passport size photographs, Photocopy of the certificates of educational qualifications, experience etc. along with original certificates.
