CIRCULAR

Sub: Filling up of the 01 (One) vacant post in the grade of Radiographer in Dr. Ram Manohar Lohia Hospital, New Delhi by deputation.

One post of Radiographer (Group 'C') Non-Gazetted, Non-Ministerial in the pay scale of Rs. 9300 – 34800 with Grade Pay of Rs. 4200/- is proposed to be filled in Dr. Ram Manohar Lohia Hospital by Deputation. The eligibility for the post is given in Annexure-I. The period of deputation shall initially be for a period of one year but in any case shall not exceed 3 years. The pay of the selected candidate will be regulated in accordance with the orders of Govt. in force as amended from time to time.

It is requested that applications of suitable candidates who are eligible, willing and can be spared immediately, may be forwarded to the undersigned within a period of 30 days, from the date of issue of the circular, in the prescribed pro-forma (Annexure-II) through concerned cadre controlling authority. The cadre controlling authorities should carefully check the applications and ensure that they satisfy the eligibility conditions before forwarding the same to this office. The application must be supported with the vigilance clearance and up to date ACR dossier.

Note: Applications may be sent to Technical Section in the prescribed Performa enclosed as Annexure-II, through proper channel within 30 days from the date of issue of the circular positively, after which no application will be accepted in any condition.

ANNEXURE - I

1. Name of the Post : Radiographer (Group "C")
2. No. of vacant Posts : 01(One)
3. Maximum age limit for appointment By deputation : 56 years as on the closing date of receipt of applications.
4. Pay Scale of the post : Level-6, Rs. 35400-112400 (pre-revised pay scale of Rs.9300-34800 + GP 4200)
5. Method of Recruitment : By Deputation
6. Eligibility Conditions for deputation : (a) (i) holding analogous posts on regular basis in the parent cadre or Department; or
(ii) with at least ten years regular service in posts in the pay band - 1, pay scale of rupees 5200-20200 with grade pay of rupees 2000 in the parent cadre or department ; or
(iii) with at least five years regular service in the pay band 1, rupees 5200-20200 plus grade pay of rupees 2400 on the parent cadre or department;
(b) Possessing the requisite qualification and experience prescribed for direct recruits under column (7).
7. Educational Qualification for Direct Recruits: Essential Qualification: (a) 12th Class pass with Science from a recognized Board.
(b) Diploma or Certificate in Radiography (Two years duration) from a recognized Institute; and
(c) One year experience in Radiography in a recognized Hospital or Medical Institute.

Note 1 : The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central or State Government shall ordinarily not exceed three years. The maximum age limit for appointment by deputation shall be not exceeding fifty six years as on the closing date of receipt of application.

Note 2 : The departmental official in the feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation shall not be eligible for consideration for appointment by promotion.

Note 3 : For the purpose of appointment on deputation basis, the service rendered on a regular basis by an officer prior to the 1st January, 2006 (the date from which the revised pay structure based on the Sixth Central Pay Commission recommendation has been extended) shall be deemed to be service rendered in the corresponding grade pay or pay scale extended based on the recommendations of the pay Commission except where there has been merger of more than one pre-revised scale of pay into one grade with a common grade pay or pay scale, and where this benefit will extend only for the posts for which that grade pay or pay scale is the normal replacement grade without any up gradation.
