Sir / Madam,

This is with reference to the written Test & skill test held on 25<sup>th</sup> October 2016 & 30<sup>th</sup> January 2017 respectively for the post of **Sr. Radiographer**. It has been decided with the approval of the Competent Authority to offer you the post of **Sr. Radiographer Group 'B' (Non Gazetted) Non Ministerial** on Temporary basis against **UR vacancy** in **Level-6, Rs. 35400-112400** (pre-revised pay scale of **Rs.9300-34800 + GP 4200**) plus usual allowances as admissible to the Central Government employees from time to time. **This offer of appointment is purely provisional subject to fulfillment of all the conditions laid down herein, and receipt of Police Verification & Verification of Educational Certificates failing which the offer of appointment shall be treated as cancelled.** The terms and conditions of this offer are given as under:

1. The terms of appointment are as follows:

- (a) The appointment to the post of **Sr. Radiographer** is being made on temporary basis from the date you assume the charge of the post. You will be on probation for a period of two years, which can be extended / curtailed by the competent authority.
- (b) The appointment carries with it the liability to serve anywhere in India.
- (c) Other conditions of service will be governed by the relevant rules and orders in force from time to time.

2. The appointment is subject to:

- (i) Production of certificate of fitness from the competent medical authority;
- (ii) Production of original certificates relating to:

- (a) Date of Birth
- (b) Technical & other qualifications required for the post.
- (c) Character certificates from two gazetted officers of Central / State Government.
- (d) Certificate of SC/ST/OBC category, if applicable, issued by the Competent Authority in the prescribed format (certificate belonging to OBC should be in accordance with the notification issued by the Govt. of India Gazette Extraordinary Part I Section I, dated 13.9.1993.) A declaration in addition to certificate issued by the Competent Authority may be furnished by the candidate seeking reservation as OBC in the enclosed format.

The appointment is provisional and is subject to the community certificate being verified through the proper channels. If the verification reveals that the claim of the candidate for Other Backward Classes or creamy layer is false, his/her services will be terminated forthwith without assigning any further reason and action as deemed fit would be taken.

- (e) Any other documents that the hospital authorities may specifically ask for.
- (f) Statement of declaration in the prescribed Pro forma of being married to a person not having more than one wife/husband living.

3. No TADA will be admissible for joining the post.
4. If any declaration given or information furnished by you is found to be false or if you are found to have wilfully suppress any material fact, you will be liable to be removed from service and also liable to such other action as Government may deem necessary under the rules in force.
5. **You will be governed by the new restructured defined Contribution Pension Scheme as notified by the Central Govt.**
6. If the said offer is acceptable to you on the terms & conditions mentioned above, you should report to the undersigned **within 30 days from the date of issue of this letter.** If you fail to report for duty by the above-prescribed date, the offer of appointment will be treated as cancelled and no further communication will be entertained in this regard.
