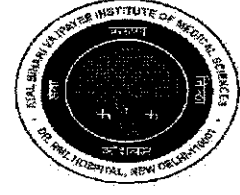

- The total fee amounting to **Rs. 51,000/- (Rupees Fifty One Thousand only)** {university charges per year Rs. 25,000/- + security deposit onetime payment refundable Rs. 10,000/- + college Tuition fee and Institution support Development fee (ABVIMS) Rs. 15,000 + student Activity fee per annum Rs. 1000/-} to be remitted in "PGIMER Student Fee Collection" **A/c No. 26020200000370**, Bank of Baroda, Dr. RML Hospital Branch, New Delhi [IFSC Code: **BARB0RAMDEL**].
- Payment can be made through online transfer/UPI (**QR Code annex-II**) after the verification of documents. No payment will be accepted by the mode of cash/debit card/credit card/cheque/demand draft etc.[copy of the receipt of payment to be produced].
- Alumni contribution fund (onetime payment) an amount of Rs. 2,000/- will be deposited by the students directly to University as and when demanded by the University.**
- The Surety Bond of **Rs. 25,000/- (Rupees twenty five thousand only) (only on Delhi stamp paper and notarised by Delhi notary only)** on Non-Judicial Stamp Paper of Rs. 100/- of Delhi in the prescribed format attached [**Annexure -III**]. ID card of surety is required.

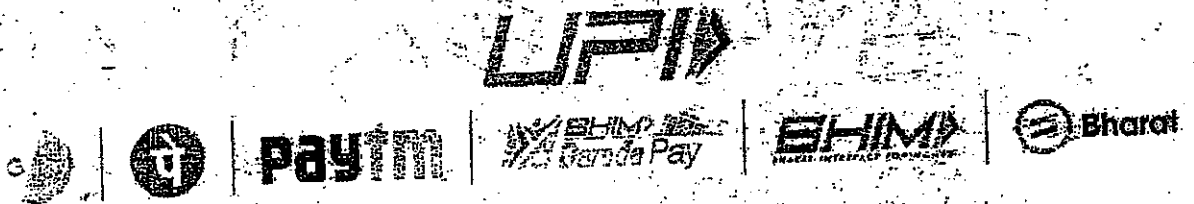

BOND FOR STUDENT SEEKING ADMISSION TO MEDICAL COLLEGE

(On a Non-Judicial Stamp Paper of Rs. 100/-)

KNOW ALL MEN BY THESE THAT WE _____ S/o W/o
D/o Sh. _____ hereinafter called the student (in case he/she complete 18 years of
age) or Father or Natural Guardian of the student (in case he/she is a minor) (which expression shall unless
excluded by or repugnant to the context include his/her heirs, administrators and assigns) and
_____ son/daughter of Sh. _____ hereinafter
called the surety (which expression shall unless excluded by or repugnant to the context include his/her
heirs, administrators and assigns) binds ourselves jointly and severally to pay to the President of
India/Governor of _____ (hereinafter called the Government) on demand
and without demur a sum of Rs. 25,000/- (Rupees Twenty Five thousand only) or if payment is to be made in
a Country other than India, the equivalent of the said sum in the currency of that Country converted at the
Official rate of exchange between that Country and India.

Whereas the Government has decided to prescribe a condition for Admission to Medical College in the
State/Union Territory of Delhi for the MBBS Course (hereinafter referred to the said course) that every,
student so admitted shall complete said Course) from the College to which he/she is admitted or from any
other Medical College in any part of the Country and that on such completion he/she shall, if so required by
the Government serve in any part of the Country in the rural areas for a minimum period of two years on
such remuneration as may be prescribed therefore and shall furnish a suitable bond for the due
performance of the said condition.

AND WHEREAS THE student who had applied for admission for the said Course in ABVIMS &Dr. RML Hospital
(hereinafter referred to as the said College) has been admitted for the said Course. NOW THE CONDITIONS
FOR THE ABOVE WRITTEN OBLIGATION IS THAT IF, ABVIMS THE STUDENT(S) SHALL:

- i. Diligently prosecute and complete the said Course at the said college or any other Medical College in
the Country and pass the prescribed University Examination for the said Course.
- ii. Within a period of 30 days from the date of his/her completion of the prior of internship or rotating
housemen-ship, give to the Govt. by registered post, notice in writing intimating, provided however
that, if the student is desirous of continuing postgraduate studies, such notice permission of the
Government in its absolute discretion to refuse such permission or grant its subject to the condition
that the student shall within one month from the completion of post graduate course, give a like
notice to the Government.
- iii. When called upon by the Government at any time within a period of Six Month from the receipt of
the notice aforesaid join the Central Health Services /State Medical Services and serve in rural area
anywhere in the state tor minimum period of Two Years at such remuneration as may be prescribed
before and in the event the student being not so called upon by the Government to join the Central
Health Services State Medical Services and serve them for two years or serve the Central or State
Government in the rural areas or the CHS or SMS tor the aggregate period of twoyears and during
the period during which the student is required to serve under the provisions of this bond faithfully
discharge the duties assigned to by Government on his/her superior with utmost diligence and
efficiency and shall observe the rules for time being in force regulating the conduct of persons so
serving.

THEN THE ABOVE WRITTEN BOND becomes void otherwise the same shall remain in full force and virtue.

AND in the event of student committing a breach of any of the above terms and conditions the whole of the Amount of Rs. 25,000/- (Rupees Twenty Five Thousand Only) or such lesser sum as the Government may in its absolute discretion decide shall become payable jointly or severally by the student or the Father/Natural Guardian of the student in case of a minor student and the above surety _____ (full name of surety) forthwith and the Government may without prejudice to any other rights and remedies of the Government recover the same from the student or the Father/ Natural Guardian of the student in case of minor student and above surety _____ PROVIDED further that the liability of the surety hereunder shall not be impaired or discharged by reasons of time being granted or any forbearance, act or omission of the Government (with or without the knowledge or consent of the surety) in respect of or in relation to the several obligations and condition to be performed or discharged by the student nor shall it be necessary for the Government to sue the student or Father/Natural Guardian of minor student before suing the surety for Amounts due hereunder and provided further that bond shall in all respects be governed by the laws of India.
