2. Emoluments: -

Pay scale Rs. 56100-1,77,500/- plus applicable admissible allowances in pay matrix (level 10) under CCS (Revised Pay) Rules, 2016 at entry level.

3. Eligibility:-

- a) MBBS from a recognized University.
- b) Should be registered with Delhi Medical Council (DMC).
- c) Only those candidates who have completed their Internship are eligible.

4. Age Limit:

- a) Relaxable 30 Years for UR, 33 Years for OBC & 35 Years for SC/ST Category as on **09.07.2020**.
- b) Age Relaxation of 10 years for Persons with Disability (15 years for SC/ST and 13 years for OBC candidates) as on **09.07.2020**.

5. Reservation:

All reservations will be considered in the above posts strictly in accordance with prescribed norms/rules.

- a) SC/ST candidates to submit copy of community/caste certificate for designated authority.
- b) OBC candidates should submit OBC Certificate as per given Annexure having date of issue on or after 01.08.2017 vide OM No. 36036/2/2013-Estt.(Res-I) dated 31.03.2016 of DOPT, Ministry of Personal & Public Grievance & Pensions, New Delhi.
- c) Persons with disability (PWD) to produce/submit a certificate issued by a competent medical authority.

6. Terms & Condition of Recruitment:

- b) Eligible candidates will present themselves for interview at <u>Academic Section</u>, <u>Academic Block</u>, <u>ABVIMS Building at 9:30 A.M.</u> on the date specified for the interview of the Junior Residents along with <u>all relevant documents in original</u> together with self attested copies of all documents in support of their candidature for the post, two Passport size photographs.
