CIRCULAR

Subject: Seeking willingness from SAG level officers of GDMO sub-cadre of CHS for posting as Director(CGHS).

A select list of SAG level officers of GDMO sub-cadre of CHS is being prepared for deciding a panel of officers for posting as Director(CGHS). The relevant rule position is as under:

- i. As per Schedule-II of CHS Rules, 2014, the post of Director (CGHS) in the Ministry is a "Duty Post" which is to be filled by an SAG level officer from amongst the GDMO sub-cadre of CHS.
 - ii. CHS (Amendment) Rules, 2019 provides that all posts belonging to CHS in Directorate Central Government Health Scheme, Ministry of Health & Family Welfare are Administrative Posts.
 - iii. Rule 56 (bb) of the Fundamental Rules, 1922 provides that the age of superannuation in respect of GDMO sub-cadre of CHS shall be 65-years and shall hold the administrative posts till the date of attaining the age of 62-years and thereafter their services shall be placed in non-administrative positions.
 - iv. In light of the above, the post of Director (CGHS) is an administrative post, which is to be filled-up from amongst a panel of SAG-level officers belonging to GDMO sub-cadre of CHS, who can hold the post of Director (CGHS) till the date such officers attain the age of 62-years.
2. Accordingly, willingness of all SAG level officers of GDMO sub-cadre of CHS, who are left with 02-years of service in attaining the age of 62-years as on 31.01.2024, are sought by 31st January, 2024 positively on email at pradeep.k13@nic.in, in the attached proforma directly to the Ministry.
