**ORDER**

WHEREAS Mr. Pavan Kumar Meena S/o Sh. Chuttan Lal Meena was appointed as **Nursing Officer** in **ABVIMS & Dr. Ram Manohar Lohia Hospital, New Delhi** on the basis of written examination (**Nursing Officer Recruitment Common Eligibility Test – NORCET-2022**) conducted by AIIMS, New Delhi in **September 2022**. His name appeared in the provisional list of selected candidates and his dossier was forwarded to this Hospital for his appointment to the post of **Nursing Officer** on a regular basis subject to his declared medically fit and verification of documents. He was appointed as **Nursing Officer** on **10.12.2022** and on probation for two years.

WHEREAS, an identity verification derive (Biometric Identity Verification) was conducted by the Hospital administration from **01.07.2024 to 24.07.2024** and on **26.07.2024** for those candidates who were selected and appointed to the post of **Nursing Officer** in this Hospital on the basis of written examination conducted by AIIMS, New Delhi in **September 2022**. The derive contained objective reproducible parameters viz. verifying the identity of the candidates through **IRIS, fingerprints, photographs** who appeared in the written exam (**NORCET-2022**) vis-a-vis the person joined to the post of **Nursing Officer** in this Hospital.


WHEREAS initially **Mr. Pavan Kumar Meena S/o Sh. Chuttan Lal Meena (Roll No. 4186758)** did not present himself for identity verification as scheduled above, he appeared on **23.08.2024** for the Biometric Identity Verification. The Biometric verification of **Mr. Pavan Kumar Meena** was carried by two organizations viz. **M/s Innovatiview** and **M/s Tata Consultancy Services** who did the Biometric Attendance during the written exam (**NORCET-2022**). As per the report of the two agencies, it was established that the **Photograph, Fingerprints** and **IRIS** of the person recorded during the written exam against **Roll No. 4186758** did not match with the **Biometric Identity verification** of **Mr. Pavan Kumar Meena** who joined this Hospital as **Nursing Officer**.

WHEREAS an Office Memorandum vide **No. NS- 11/3/2024-Nursing Section-Dr. RMLH/1746** dated **10.10.2024** was issued to **Mr. Pavan Kumar Meena, Nursing Officer** informing him the findings of the **Biometric Identity verification** derive and to show cause as to why the disciplinary action should not be taken against him.

WHEREAS **Mr. Pavan Kumar Meena** vide his reply dated **15.10.2024** failed to give explanation or any documentary evidence against the **OM dated 10.10.2024** as to why his **Photograph, Fingerprints** and **IRIS** did not match during the **Biometric Identity verification** derive with the person who appeared in the written exam held in **September 2022**.

AND WHEREAS on a careful consideration of the report of the **Biometric Identity verification**, the undersigned has come to the conclusion that **Mr. Pavan Kumar Meena S/o Sh. Chuttan Lal Meena** has committed forgery and fraudulently obtained the order of appointment. Therefore, the appointment of **Mr. Pavan Kumar Meena, Nursing Officer** is void and bad in law. In pursuance of **DoPT O.M. No. 36011/1/2012-Estt(Res)** dated **10<sup>th</sup> January, 2013**, judgment of Hon'ble Supreme Court of India dated **21<sup>st</sup> July, 2016** in **SLP(C) Nos. 4757/2014** and **24320/2014** and **Vigilance Manual 2013**, **Mr. Pavan Kumar Meena** cannot be allowed to retain in public service and should be terminated from the service.

NOW, THEREFORE, keeping in consideration of the above, the undersigned terminate forthwith the services of **Mr. Pavan Kumar Meena S/o Sh. Chuttan Lal Meena, Nursing Officer**.
