- Ph. D from a recognized institution or equivalent.

- 3 publications in indexed journal as first/corresponding author.

- M. Phil in Clinical Psychology from a recognized institution or equivalent. (Ph.D. is desirable.)
- 2 years teaching experience as Lecturer or as Clinical Psychologist in Department of Clinical Psychology conducting M. Phil program.
- 2 research publications in indexed journal as first/corresponding author.
