CIRCULAR

Sub: Filling up of the 01 (one) post of Audiologist on deputation basis in Dr. Ram Manohar Lohia Hospital, New Delhi on deputation (including short term contract).

One post of Audiologist (Group 'B') Non-Gazetted, Non-Ministerial in the Pay Level-7 (Pay matrix of Rs.44900-142400/-) is proposed to be filled in Dr. Ram Manohar Lohia Hospital on deputation (including short term contract). The eligibility for the post is given in Annexure-I. The period of deputation shall initially be for a period of one year but in any case shall not exceed 3 years. The pay of the selected candidate will be regulated in accordance with the orders of Govt. in force, as amended from time to time.

It is requested that applications of suitable candidate(s) who are eligible, willing and can be spared immediately, may be forwarded to the undersigned within a period of Forty Five days, from the date of publication of Advertisement in the Employment Newspaper, in the prescribed pro-forma (Annexure-II) through concerned Cadre Controlling Authority. The Cadre Controlling Authorities should carefully check the applications and ensure that they satisfy the eligibility conditions before forwarding the same to this office. The application must be supported with the vigilance clearance and up to date ACR dossier.
