It is informed to all concerned that Mop-up round for document verification for 2nd round of joining process of Nursing Officers in '4' Central Govt. Hospitals for the candidates which may not be able to attend the document verification from 06/09/2021 to 17/09/2021 as per schedule due to condition(s) beyond his/her control, will be held on 27/09/2021 from 10.00 AM to 3.00 PM at Auditorium, ABVIMS & Dr. Ram Manohar Lohia Hospital, New Delhi-110001. However, in such cases, the candidates will not be allowed to claim order of preference for allocation of Hospital.

It is further informed that if any candidate do not attend the document verification process as per schedule w.e.f. 06/09/2021 to 17/09/2021 and on mop-up round which is scheduled to be held on 27/09/2021, it will be presumed that he/she is not willing to join for the post of Nursing Officer in any of '4' Central Govt. Hospitals and his/her candidature for the post of Nursing officer against the Recruitment Notice No. 1/2019 of AIIMS, New Delhi and Recruitment Notice No. 1/2019(RRC) of Dr. R.M.L. Hospital, New Delhi will be treated as cancelled. No further correspondence will be entertained in this regard in any case.

FREQUENTLY ASKED QUESTIONS

Q.1 I have lost my admit card/application form etc.. May I attend document verification process as per schedule?

Ans. Yes. Please (√) in the appropriate column e.g. if lost, please √ 'No', in Check-list and attend the process of document verification as per schedule. However, the final decision on the lost document will be taken by the Competent Authority after the completion of document verification process and will be intimated either to the candidate on his/her registered e-mail id or displayed on the website www.rmlh.nic.in, www.vmmc.sjh.nic.in, www.lhmc-hosp.gov.in accordingly in due course of time.

Q.2 I am not able to attend document verification process as per schedule for reason(s) beyond control. May I be called for document verification at later stage?

Ans. Yes. The mop-up round for such candidates will be held on 27.09.2021 from 10:00 AM to 03:00 PM at Auditorium, ABVIMS & Dr. Ram manohar Lohia Hospital, New Delhi-110001. Please also see Note-6 of the Notice under F.No. 5-80/2019-RMLH/NS dated August, 2021 followed by Notice under F.No. 5-80/2019-RMLH/NS/4033 dated 27th August, 2021 published on the website of '4' Central Govt. Hospitals.

Q.3 I have joined AIIMS, New Delhi against Recruitment Notice No. 1/2019 of AIIMS, New Delhi and Recruitment Notice No. 1/2019(RRC) of Dr. R.M.L. Hospital, New Delhi. May I attend document verification process for joining any of '4' Central Govt. Hospitals?

Q.4 I have an OBC (NCL)/EWS certificate in Central government format. Am I required to obtain a fresh OBC (NCL)/EWS certificate at the time of document verification?

Q.5 I have been working in Govt. Service/Autonomous body, but it may not be possible to get 'NOC' at the time of document verification. May I appear for document verification process?

Ans. Yes. However, in case of selection, the offer of appointment will be issued only after the submission of 'NOC' from the concerned employer.
